Subject:- Cancellation of appointment of Draftsman (Civil).  
Government Order No: 66-PW(R&B) of 2017  
Dated:22 -02-2017

**WHEREAS**, J&K Services Selection vide letters No. SSB/Secy/Sel/2016/ 16120 -26 dated 09.06.2016 and No. SSB/Secy/Sel/2016/13656-62 dated 18.05.2016 has forwarded the select list of 68 candidates for appointment to the post of Draftsman (Civil) (**Divisional Cadre Jammu/Kashmir**) in the Public Works (R&B) Department; and

**WHEREAS**, on the basis of the recommendations made by J&K SSB, Government Order No. 214-PW(R&B) of 2016 dated 04.07.2016 and Government Order No. 217-PW(R&B) of 2016 dated 07.07.2016 appointment orders in favour of the recommended candidates have been issued ; and

**WHEREAS**, among other condition, the aforementioned government orders dated 4.7.2016 & 7.7.2016, specifically provided that the appointees shall report to the Chief Engineers, PW(R&B) Kashmir/Jammu within a period of 21 days from the date of issuance of the order; and

**WHEREAS**, the following 12 candidates (06 from Jammu Division &06 from Kashmir Division) appointed as Draftsman (Civil) (**Divisional Cadre Jammu/Kashmir**) in Public Works (R&B) Department vide aforementioned Government orders have failed to submit their joining report within the stipulated/prescribed period:-

**WHEREAS**, vide this department's letter No. PW(R&B)NG/49/2016 dated 30.12.2016, a notice was served upon the above mentioned appointees to report in the Chief Engineers PW(R&B) Jammu within a period of 07 days, failing which it shall be construed that they are not interested to take up this job and their appointment, as Draftsman (Civil) in the PW(R&B) Department shall be cancelled without further notice; and

**WHEREAS**, Chief Engineer, PW(R&B), Kashmir vide his letter dated 10.01.2017 has intimated that these candidates have failed to join within the stipulated time period as these candidates have already been appointed by virtue of another Government order No. 183-PW(R&B) of 2016 dated 13.06.2016 and No. 214-PW(R&B) of 2016 dated 04.07.2016 and they are working in the department. Chief Engineer, PW(R&B), Jammu vide his letter dated 09.01.2017 has intimated that none of these Draftsman (Civil) has joined in this office as these candidates are already working in the Department as have already been appointed vide Govt. order No. 184-PW(R&B) of 2016 dated 13.06.2016; and

**NOW THEREFORE**, it is hereby ordered that in view of their failure in joining with the Chief Engineers, PW(R&B) Jammu/Kashmir, the appointment of above 12 candidates, as Draftsman (Civil) (**Divisional Cadre Jammu/Kashmir**) in Public Works (R&B) Department made vide Government Order No. 214-PW(R&B) of 2016 dated 04.07.2016 and Government Order No. 217-PW(R&B) of 2016 dated 7.7.2016 is hereby deemed to have been cancelled ab-initio.
