- ii. Director Finance of the Department shall vouchsafe the availability of funds under relevant head of account.
- iii. All codal formalities are fulfilled.
- iv. Advance payment if any be made, shall be adequately secured and properly guaranteed before the release of actual payment.
- v. The Technical sanction/administrative approval shall be obtained prior for undertaking the said work from the competent authority.
- vi. The expenditure shall be incurred strictly as per the guidelines of the scheme and conditions laid down in the sanctioned letter of the concerned Ministry, Govt. of India
