Subject: - Placement of I/c Assistant Engineers (Civil) as I/c Assistant Executive Engineer (Civil) Degree/ Diploma.

Whereas, the department received vacancies of Assistant Executive Engineers (Civil) from various Chief Engineers/ HODs which aggregated to 122 in number.

Whereas, vide SROs 661 & 662 dated 25th October, 2019, the cadre strength of Assistant Executive Engineers (Civil) for the Union Territory of J&K & Ladakh is 441;

Whereas, in compliance to O.M No. GAD/MTG/RB-IV/04/2016 dated 21.06.2016, of the General Administration Department, twenty (20) posts (04 degree + 16 diploma) of Assistant Executive Engineers (Civil) have been kept reserved in earlier placements;

Whereas, as per SRO-297, dated 14.09.2006 the post of AEE is to be filled from 80% by promotion from Assistant Engineers (degree holders) having 02 years of service as AE and 20% by promotion from diploma holders having 04 years of service as AE;

Whereas, accordingly on the basis of present incumbency of Assistant Executive Engineers (Civil) and cadre strength of both (Degree and Diploma) the net resultant vacancies in favour of degree and diploma comes to 41 and 61 respectively as shown in the table below:-

Whereas, after applying the roster and further keeping the slots/ vacancies reserved for various reserved categories as per GAD OM No.GAD/MTG/RB/-18/04/2016 dated 21.06.2016 it requires to 14 and 16 respectively in favour of degree and diploma holders. Accordingly total slots reserved in compliance to General Administration Department OM comes to 18 in favour of degree holders and 32 in favour diploma holders. This exercise provides 27 posts of AEE's available for degree holders and 45 posts available for diploma holders for promotion;

Whereas, for the purpose of promotion Final Seniority List of Junior Engineers (civil) degree holders issued vide Govt. order No. 460-PW(R&B) of 2019 dated 22.01.2019 and Final Seniority List of Junior Engineer (Civil) diploma holders issued vide Govt. order No. 267-PW(R&B) of 1997 dated 28.04.1997 have been taken into account. Three streams available for making above mentioned promotion from AE to AEE

1. AE Degree Holder. (promotee)
2. AE Diploma Holder (promotee)
3. AE Direct Recruit.

The claim of AE's appointed through JKPS (Direct Recruit) in 2016-17 has not been considered as they became eligible during the year 2018-19, whereas promotee AE's have become eligible in 2015 i.e prior to Direct Recruit, eligibility, placement to the post of AEE is considered on eligibility as well as available vacancy.

Whereas, the necessary documents/ APRs/ Vigilance Clearance is available only in favour of 24 eligible degree holders and 15 eligible diploma holders and hence keeping 03 no. of posts of AEE for degree holders & 25 no. of posts for diploma holders on hold till all their requisite documents are received from the concerned HODs/ Chief Engineers;

Now therefore, in view of the above given circumstances, sanction is hereby accorded to the placement of following eligible I/C Assistant Engineers (Civil) as I/C Assistant Executive Engineers (Civil) Degree/ Diploma in their own pay and grade for a period of six months or till confirmation by the JK PSC whichever is earlier:
