The Administrative Approval is subject to the fulfillment of following conditions:-

1. The works shall be executed after observing all Codal /procedural formalities.
2. The detailed estimate of works shall be technically sanctioned by the competent authority.
3. It must be ensured that there shall be no multisource of funding or overlapping of schemes under different programmes.
4. That no diversion of funds from one scheme to another scheme shall be made.
5. The funds shall be released by the controlling officer to the extent of actual work done as per approved provisions in the estimate after fulfilling all Codal /procedural formalities.
6. That the works are executed strictly as per provisions and specifications of the sanctioned estimates.
7. Schemes / project shall be completed within stipulated time.

8. *The projects are designed as per latest relevant I.S. Codes and specifications of MoRTH/PWD/CPWD and same is authenticated and proof checked by the competent authority. While designing, latest HFL has to be taken into consideration.*
9. *Standard specifications/Quality control shall be maintained in accordance with standards set under MoRTH/ CPWD/IRC Code and I.S. Standards.*
10. *Rates for the items, not covered in JK SSR or any other relevant schedule, shall conform to Analysis of rates based on authentic Data Book, to be computed and approved by the competent authority well before invitation of tenders in accordance with set codal procedures.*
11. *E-tendering mode is followed for fixation of the award of contract for execution of the projects. Fragmentation of project, while tendering, is not allowed.*

The expenditure on this account shall be debit able to relevant account head.
