Sanction is hereby accorded to the temporary appointment of Mr. Shahnawaz Ahmad Dar S/o Late Abdul Hamid Dar (Ex-Chauffeur) R/o Kursoo Rajbagh Tehsil and District Srinagar, as Orderly (Class-IV) in the pay Level SL-1 (14800-47100) in the Public Works (R&B) Department, District Srinagar, in relaxation of the prescribed qualification in terms of Rule-7 of SRO-43 of 1994.

The appointee shall report to the Chief Engineer PW(R&B) department, Kashmir within a period of 21 days from the date of issuance of this order and shall be allowed to join only on production of the following documents/certificates (in original) to be verified subsequently:-

- i. Academic Qualification Certificate.
- ii. Date of Birth Certificate.
- iii. Domicile Certificate.
- iv. Health Certificate from the concerned Chief Medical Officer of the District.
- v. Dependent Certificate issued by the Assistant Commissioner, Revenue.
- vi. No loan certificate under Self Employment Scheme from DIC concerned and Employment Department.
- vii. All other relevant documents as are required under SRO-43/1994.

The appointment of the appointee, shall further be subject to the following conditions:-

- (a) That he/she shall give an undertaking in the shape of an Affidavit to the effect that:
  - (i) In case adverse report about his/her Character and Antecedents is received from the Inspector General of Police, (CID), J&K, to whom a reference shall be made by the Chief Engineer PW(R&B), Kashmir, he/she shall have no right to claim his/her appointment as Orderly (Class-IV) in Public Works (R&B) Department and his/her appointment, as such, shall be deemed to have been cancelled ab-initio;

- (ii) If, on verification, genuineness of the qualification certificates from the concerned issuing authority is found that the same is fake/forged, the claim of the appointee for appointment as Orderly (Class-IV) shall also be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him/her.
- (b) The salary of the appointee shall not be drawn and disbursed to him/her unless a satisfactory report in respect of (i) and (ii) above are received in his/her favour.
- (c) The appointee shall be initially on probation for a period of two years.
- (d) The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24.12.2009.
- (e) If the appointee fails to join within a period of 21 (twenty one) days from the date of issuance of this order he/she shall forego his/her right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.
