Sanction is accorded to the advance drawl of an amount of Rs.1.35 Crore (Rupees One Crore Thirty Five Lakhs)) only in favour of Chief Engineer, Mechanical Engineering Department, Kashmir for Procurement of Snow Clearance Vehicles, subject to the following conditions.

- i. Accounts Officer (MED), shall vouchsafe the availability of the funds under Capex 2020-21;
- ii. The funds shall be utilized after observing all the required codal formalities;
- iii. Proper and transparent e-tendering procedure has been followed in letter and spirit;
- iv. The expenditure shall be made on admissible items only as approved by the Competent Authority;
- v. The funds shall not be drawn just to park in the bank account but incurred for the purpose they are meant for;
- vi. The UCs/Red D.C Account shall be furnished to the concerned quarters within stipulated time but before 31-03-2021;
- vii. Approval of competent authority wherever required shall be duly obtained.


