Subject: Reorganization/ restructure of Public Works (R&B) Department.



Government Order No. 319-PW(R&B) of 2023 Dated: 02.08.2023

In pursuance to above referred Government orders and Government Order No. 93-JK(GAD) of 2023 dated 26.07.2023, it is hereby ordered that:-

- 1. Engineering/Non-engineering staff of subsumed engineering wings of other departments shall be deemed to have been relieved from their respective departments by 14th of August 2023 and shall join in the office of Development Commissioner Works (Engineer-in- Chief, J&K) on next working day viz 16th of August 2023. Engineer- in-Chief, J&K shall submit the report of the staff having joined in his office, to the Administrative Department Public Works (R&B) Department by 4:00 PM on 16.08.2023.
- 2. Measurement Books of all works with all the subsumed engineering units shall be closed by 10th of August and accordingly all the records pertaining to the ongoing works shall be digitized by 10th of August and copy of same be shared with the present Administrative Department, PW(R&B) Department and with the respective Chief Engineers of R&B Kashmir/Jammu by the respective subsumed engineering unit head.
- Details of all ongoing works (CD Block wise) to be compiled as per annexure to this order and duly certified by the respective DDO by 10th August and a copy submitted to Administrative Department and Chief Engineer R&B Kashmir/Jammu.
- 4. In order to save the time, space and govt exchequer, the infrastructure, vehicles, furniture and fixture in use with the subsumed engineering wings of other departments shall be used by the respective restructured engineering units of the R&B Department to the extent possible with due permission of



units of the R&B Department to the extent possible with due permission of the owner department. The relieved engineers of subsumed engineering ensure their departure alongwith these articles from the respective subsumed engineering units, however, the inventory of these items shall have to be shared with respective Administrative Departments and the Chief Engineer of R&B Kashmir/Jammu by the head of the subsumed engineering wing.

- 5. It shall be the personal responsibility of head of the subsumed engineering units to comply with the above directions, failing which disciplinary actions shall be initiated against the delinquents
- 6. This order shall be treated as notice for initiating disciplinary action.
