The appointees shall report in the office of Chief Engineer PW(R&B) Department Kashmir within a period of 30 days from the date of issuance of this order. His/her joining report shall become effective only after he/she executes an agreement in the "Form" prescribed under Jammu and Kashmir Migrants (Special Drive) Recruitment Rules, 2009 issued under notification SRO No. 412 of 2009 dated 30.12.2009. He/ She

shall be allowed to join only on the production of following certificates/documents in original:-

1. **Education/Technical Qualification Certificates/marks Sheet, which will also include whether technical degree/diploma is approved for employment in J&K.**
2. **Date of birth certificate/Matriculation Certificate.**
3. **Permanent Resident Certificate/State Subject.**
4. **Migration certificate of being a Kashmiri Migrant duly issued in the Office of Relief & Rehabilitation (Migrants).**
5. **Age and Health Certificate issued by an officer not below the rank of Chief Medical Officer.**
6. **Certificate from concerned authorities to the effect that no loan under self-employment scheme has been obtained/ availed by the concerned candidate.**
7. **Reserved category certificate, wherever required.**
8. **Any other relevant certificates are required under rules.**

The appointment order of Junior Engineers (Civil) under Prime Minister's Special Package shall be deemed to be cancelled ab-initio, in case, at any stage, it emerges that the certificates/documents produced by the concerned are fake or forged.

In case, any appointee fails to join within the stipulated period of 30 days, his/her appointment shall stand cancelled without any further notice.

The appointment shall be subject to the following conditions:-

- i. **Appointee shall give an undertaking in the shape of an affidavit that in case any adverse report about his/her character and antecedents is received from Additional Director, General of Police, CID, Kashmir (to whom a reference shall be made by the Chief Engineer), the candidates shall have no right to claim their appointment as "Junior Engineer (Civil)" and his/her appointment as such shall be deemed to be void ab-initio and cancelled as such.**
- ii. **A person convicted by the Competent Court of an offence involving moral turpitude, heinous offences like murder, rape, docility, robbery and offences under NDPS Acts shall be regarded not fit for Govt. Service.**
- iii. **Salary of the appointee shall not be drawn and disbursed unless satisfactory character and antecedents report is received from ADGP, CID J&K and verification of relevant certificate/documents is received from the concerned authorities.**
- iv. **The appointment order shall be governed under new pension Scheme as per SRO-400 dated 24.12.2009.**
- v. **The appointment of the candidates as "Junior Engineer (Civil)" shall be subject to outcome of the writ petition(s) if pending in any court of law.**

In case, the appointee migrates from Kashmir Valley at any time during his/her service tenure, for any reason what so ever, his/her appointment/service shall stand terminated without any notice by itself by the action of his/her migration.

The appointee shall be on probation initially for a period of 02 years.
