**Subject: Appointment of Shri Rajinder Singh S/o Amar Jeet Singh R/o Gadpora, Tral against the post of Class-IV vacancy.**

Sanction is hereby accorded to the regular temporary appointment of Mr. Rajinder Singh S/o Shri Amar Jeet Singh R/o Gadpora Tral against Class-IV vacancy in the pay band of Rs 4440-7440 + grade pay 1300/- (PR) in R&B Construction Division 2nd Srinagar, PW(R&B) Department Kashmir in the relaxation of rules.

The appointee shall be governed by the provisions of SRO 400 of 2009 dated 24.12.2009 issued by the Finance Department.

The appointee shall be on probation for a period of two years and shall be allowed to join only on the production of the following certificates/documents in original.

- i. Education/Technical Qualification certificates/marks sheet, which will also include whether technical degree/diploma is approved for employment in J&K.
- ii. Date of birth certificate/Matriculation certificate.
- iii. Permanent Resident Certificate/State Subject.
- iv. Age and Health Certificate issued by an officer not below the rank of Chief Medical Officer.
- v. Certificate from concerned authorities to the effect that no loan under self-employment scheme has been obtained/availed by the concerned candidate.
- vi. Reserved category certificate, wherever required.
- vii. Any other relevant certificates as required under rules.

The above appointment shall be valid subject to inspection and verification of all certificates in original.

The Chief Engineer, PW (R&B), Kashmir shall ensure that all the certificates are got inspected in original and subsequently got verified duly and diligently from the relevant issuing authorities and establish the genuineness of Qualification/Certificate/PRC/Domicile status of concerned district for a period not less than 15 years except Schedule Caste.

If at any later stage, it comes to fore that any of the certificates are fake or that the qualification acquired is from a non recognized institute/university, the appointment shall be deemed to be void ab initio and cancelled.

Further, the appointment shall be provisional and subject to the following conditions:

- i. the appointee shall give an undertaking in the shape of an affidavit that in case any adverse report about his character and antecedents is received from Additional Director, General of Police, CID, Jammu and Kashmir (to whom a reference shall be made by the Chief Engineer), the candidate shall have no right to claim his appointment and his appointment as such shall be deemed to be void ab-initio and cancelled as such.
- ii. Salary of the appointee shall not be drawn and disbursed unless satisfactory character and antecedents report is received from ADGP, CID J&K and verification of relevant certificates/documents is received from the concerned authorities.
- iii. The inter se seniority shall be fixed separately.
- iv. The appointment of the candidates shall be subject to outcome of the writ petition(s) pending in any court of law.

The appointee shall report to the Chief Engineer, PW(R&B), Kashmir within 21 days from the date of issuance of this order.
