Whereas, on the recommendations of the J&K Public Service Commission amongst others, the following candidates were appointed as Assistant Engineers (Civil), vide Government Order No.146-PW(R&B) of 2017 dated 12-04-2017 under the categories shown against each:-

Whereas, the appointees hailing from Jammu/Kashmir Divisions were directed to report to Chief Engineer, PW(R&B) Jammu/ Chief Engineer, PW(R&B), Kashmir and those hailing from Ladakh/Kargil Province were directed to report concerned Superintending Engineers PWD Circles Leh/Kargil for joining within the prescribed time period of 21 days from the date of issuance of appointment order;

Whereas, as reported by Chief Engineer PW(R&B) Kashmir vide letter No.CE/RBK/ES/5337 dated 13-06-2017, the above referred candidates have not submitted their joining reports within the stipulated time period;

Whereas, by not joining in the office of the Chief Engineer, PW(R&B) Kashmir within the stipulated period of 21 days by candidates listed above their appointment as Assistant Engineers in PW(R&B) ordered vide Government Order No.146-PW(R&B) of 2017 dated 12-04-2017 is liable to be cancelled ab-initio;

Whereas, the above candidates through a medium of 'Notice' issued under endorsement No.PW(R&B)G/114/2017 dated 04-07-2017 were informed

that the department proposes to cancel their appointments as Assistant Engineers (Civil) in PW(R&B) Department. However, in case they have anything to state in response, they may do so in writing to the Commissioner/Secretary to Government, PW(R&B) Department within a period of 10 days of publication of the 'Notice'; and

Whereas, the copy of the 'Notice' was endorsement to Director, Information, J&K with the request to have the said notice published in at least two leading dailies of each province; and

Whereas, despite lapse of about a month, no response has been received from any of these candidates.

Now, therefore, in view of the above elucidated facts, the appointment of the aforementioned candidates as Assistant Engineers in Public Works (R&B) Department ordered vide Government Order No. 146-PW(R&B) of 2017 dated 12-04-2017 shall be deemed to have been cancelled ab-initio:


