Final Seniority of Executive Engineers (Mechanical) of Public Works (R&B) Department as it stood on 01.09.2016.

Government Order No: 392 -PW(R&B) of 2018

Dated: 09 .07.2018

Whereas, the final seniority list of Superintending Engineers issued vide Government Order number 465– PW(R&B) of 2012 dated 15-10-2012 has exhausted fully, as all the officers figuring in that list have retired on superannuation and sufficient posts are now available for regularization of services of Executive Engineers (Mechanical) as Superintending Engineers (Mechanical); and

Whereas, on the recommendation of the J&K Public Service Commission orders of regularization were issued in favour of 87 Executive Engineers of Public Works Department Mechanical wing , vide Government Order no. 379-PW(R&B) of 2014 dated 20-08-2014 and Govt Order No 220-PW(R&B) of 2016 dated 19-07-2016; and

Whereas, vide Government Order Nos 236 and 239 of 2016 dated 11.08.2016 tentative seniority lists of Executive Engineers (Mech) were issued by the Department for inviting objections ,if any, from the members of the service; and.

Whereas, in response to the same, objections were received related to the said tentative seniority lists from the following officers:-

I. Shri Fareed Ahmad Chowdry.II. Shri Amresh Raina and Othrs.

Whereas, during the course of examination of these objections in the department, two writ petitions were filed before the Hon'ble High Court, one by Shri Fareed Ahmad Choudhty and another from Shri Amresh Raina & Others bearing SWP No 1183 of 2017 titled Fareed Ahmad Choudry v/s State and SWP No. 2047/2016, titled Amresh Raina & others V/s State and Othrs respectively.

Whereas, the case SWP No 1183 of 2017 titled Fareed Ahmad Choudry v/s State has been disposed off by the Hon'ble High Court vide order dated 21.06.2017 with the following directions:-

"....Accordingly, writ petition is admitted to hearing and is disposed of with the direction to the respondents to accord consideration to the representation, stated to be filled by the petitioner for settlement of his seniority, strictly in terms of the applicable rules. Let appropriate order with regard to the settlement of the seniority of petitioner be passed within a period of three weeks from the date of receipt of copy of this order.

The writ petition is accordingly disposed of."

Whereas, the Hon'ble High Court vide Order dated 26.09.2016 passed in SWP No. 2047/2016, M.P No.1/2016 titled Amresh Raina & others V/s State & others ,has been pleased to admit the said writ petition and to issue the following directions:-

"In the mean time, subject to objections and till next date of hearing before the Bench, the official respondents may make the incharge arrangements to the posts of Chief Engineer by considering all eligible's. However, before doing so, the objections to the tentative seniority list filed by the petitioner shall be considered and appropriate orders passed thereon".

Whereas, the representations dated 16.01.2015 and 18.01.2017, filed by Shri Fareed Ahmad Choudhary stands examined in the Department in compliance to the Court order dated 21.06.2017 passed by the Hon'ble Court in SWP 1183/2017, where under he has represented for revisiting of his seniority position and maintenance of proper inter-se seniority between him and Shri Gagan Jyoti at the level of Assistant Engineer Executive issued vide Government Order number 113-PW(R&B) of 2005 dated 30-03-2005, invoking application of procedure for drawing inter-se seniority of reservation background candidates under rule 19 of SRO 126 of 1994 of J&K Reservation Rules -applicable then; and

Whereas, the above contention raised by Shri. Fareed Ahmad Choudhty in his representation has been examined in the Department and it has been observed that Shri Gagan Jyoti (SC) and Shri Fareed Ahmad Choudhary (ST) appear neck to neck with each other in the tentative seniority list and after its consideration the matter stands taken up with the J&KPSC for their consideration/decision. The inter-se seriatim of these two officers shall be subservient to the decision/recommendation of J&KPSC.

Whereas, the contention raised by Shri Amresh Raina in his objection has been examined by the Department and was considered. It came to fore that the regularization at the level of Executive Engineer Mechanical has been already settled by the J&KPSC in the year 2014 i.e. before the pronouncement of judgement on reservation by the Hon'ble High Court in Ashok Kumar Sharma's case and that presently the matter of application of catch up rule and reservation in promotion is subjudice before the Hon'ble Supreme Court in SLP No SLP(C) No 32820 of 2015 titled Mohammad Hanief Lone V/s Ashok Kumar Sharma; and Asgar Ali's case and during the pendency of the said issue, department cannot revisit the settled issue of reservation in promotion as decided earlier from time to time. Moreover, no reservation in promotion beyond the level of Executive Engineer is applicable /permissible under rules; and.

Whereas, non availability of final seniority list at the level of Executive Engineer (Mech) is hampering the process of regularization of Superintending Engineer Mechanical, jeopardizing service interests of number of other officers figuring in the seniority list/consideration zone.

Now, therefore, in view of the above explained position, for attending larger interests of the members of the Mechanical Wing, the final seniority list of Executive Engineer (Mech), forming annexure "A" to this Govt. order, prepared on the basis of recommendation of J&KPSC/DPC, is herby issued with immediate effect. The position allotted to candidates in the seniority list shall be subject to:-

a. Final Outcome of petitions related to the application of Reservation and Catch up Rules pending before Hon'ble Supreme Court/ Hon'ble High Court or any other Competent Court of law.

b. The Seniority Position of Shri Fareed Ahmad Choudhary and Shri Gagan Jyoti will be subject to the recommendation of JKPSC/DPC/Hon'ble Court of law

c. The date of birth of the officers shall be subject to the verification

/authentication from service records.
