Whereas, as per provisions of J&K Engineering (Subordinate) Service Recruitment Rules, 1997, a Junior Engineer Grade-II, Diploma Holder after acquiring degree in relevant branch of engineering is to be treated as degree holder for the purpose of seniority from the date of completion/passing of Degree; and
