Subject: Cancellation of appointment of Wasim Fidah Khan S/o Fidah Hussain Khan R/o Bemina Budgam(Draftsman Mechanical) State Cadre.

**Government Order No. 05 - PW of 2018**  
**Dated:- 03 -01 - 2018**

Whereas in item No. 105(3) of 2012 in the main select list issued vide letter No. SSB/Secy/Sel/2016/19048-14 dated 31-08-2016 and letter No. SSB/Sel/Secy/2017/1794-97 dated 07-02-2017, the Service Selection Board recommended, among others, the name of Wasim Fidah Khan S/o Fidah Hussain Khan R/o Bemina Budgam for the post of Draftsman, Mechanical, State Cadre Post **(04/OM/105)** in R&B Department.

Whereas on the recommendations of J&K SSB, among others Mr. Wasim Fidah Khan S/o Fidah Hussain Khan R/o Bemina Budgam was appointed as Draftsman, Mechanical, State Cadre under OM category in PW(R&B) Department vide Government Order No. 195-PW(R&B) of 2017 dated 09-06-2017 and directed to report Chief Engineer, MED Kashmir subject to the production of documents/certificates in original and subject to the condition that in case if at any stage it comes to fore that any of the certificates are fake or that the qualification received is from a non-recognized Institute/University, the appointment shall be deemed to be void ab-initio and cancelled.

Whereas Chief Engineer Mechanical Engineering Department Kashmir has processed the case of verification of Technical Qualification certificate and other requisite documents of the incumbent (Wasim Fidah Khan S/o Fidah Hussain Khan R/o Bemina Budgam) and in response to the correspondence of Chief Engineer, Mechanical Engineering Department Kashmir's Office in this case, the Punjab State Board of Technical Education and Industrial Training, Chandigarh vide their letter No.PSB/ITI/Verification/2017/1758 dated 11-07-2017 stated that the certificate produced by the appointee has been checked and found invalid as per their records. Accordingly, Chief Engineer, Mechanical Engineering Department Kashmir



submitted his report to the Administrative Department for necessary action in the matter.

Now therefore, the appointment of Mr. Wasim Fidah Khan S/o Fidah Hussain Khan R/o Bemina Budgam as Draftsman, Mechanical, State Cadre under (04/OM/105) vide Government Order No. 195-PW(R&B) of 2017 dated 09-06-2017 figuring at Serial No. 05 is hereby cancelled abinitio.
