Whereas, Baba Ghulam Shah Badshah, University, Rajouri is accredited by All India Council for Technical Education (AICTE).

Whereas, the above incumbents have also produced undertakings in the shape of Affidavits dully attested by the 1<sup>st</sup> Class Judicial Magistrate, affirming therein that "in case any information about their Degrees is found fraudulent/ bogus at any time during service, the same shall be deemed to be cancelled ab-initio and action as warranted under rules shall be initiated against them in terms of J&K Civil Services (Classification, Control & Appeal) Rules, 1956".

Whereas, it has been found that there is a case to accept their Degree from the date of passing Degree and include their names at appropriate places in the relevant seniority list of JE(Civil) Degree Holders as and when the same is notified afresh and also exclusion of their names from the seniority list of JE(Diploma holders).
