NOTICE

WHEREAS, as per provisions of J&K Engineering (Subordinate) Service Recruitment Rules, 1997, a Junior Engineer under the category of Diploma Holders after acquiring Degree in relevant branch of Engineering is to be treated as 'Degree holder' for the purpose of seniority from the date of completion/passing of Degree; and

The objection(s) should reach Principal/Secretary to Government, PW(R&B) Department through Chief Engineer concerned within a period of 21 days from the date of issuance/publication of this notice. No claim, whatsoever, shall be entertained after expiry of stipulated time period.
