Sanction is hereby accorded to the establishment of Road Safety Audit Cell in the Directorate of Design, Inspections & Quality Control, J&K.

- 2) It is further ordered that:
  - a) The Road Safety Audit Cell shall be headed by an officer of Superintending Engineer at the State level who shall work under the overall control and guidance of the Chief Engineer, Design Inspections & Quality Control.
  - b) The Road Safety Audit Cell shall comprise two sub cells, one for Jammu and another for Kashmir/Ladakh each headed by an officer of Executive Engineer level.
  - c) The Chief Engineer, Design Inspections & Quality Control (DIQC) J&K shall provide office accommodation for establishment of the cell in both the provinces alongwith the requisite infrastructure.
  - d) The Chief Engineer, Design Inspections & Quality Control (DIQC) J&K shall also provide clerical and other requisite staff for both the audit cells by internal adjustment.
  - e) The PW(R&B) Department shall depute engineering staff to Directorate of Design Inspections & Quality Control from overall cadre strength and by internal adjustment of the staff till posts are created.
  - f) The Road Safety Audit Cell shall be the nodal agency in the State for Engineering aspects of Road Safety. The cell shall vet the projects for road safety purposes as per the National Standared of Indian Road Congress (IRC) as envisaged in Govt Order No 46-PW(R&B) of 2016 dated 17-02-2016 and also undertake safety audit of existing roads and ongoing / existing bridges/ flyovers as envisaged in Govt Order No 139-PW(R&B) of 2016 dated 04-04-2016.

- g) It shall also be entrusted with overall monitoring and consideration of all road safety measures as envisaged in the recommendations of the committee on Road Safety of Hon'ble Supreme Court.
- h) The Chief Engineer DIQC J&K shall project the additional requirement of funds on account of various object heads for meeting day to day requirement of the cells under Non-Plan Budget (RE 2016-17).
