Whereas, on the recommendations of the Services Selection Board, J&K conveyed vide No. SSB/Secy/Sel/Class-IV/2021/7103-11 dated 18.10.2021 and General Administration Department's O.M. No. GAD/MTGRBIV/63/2021-09-GAD dated 19.10.2021, Shri Sahil Sharma S/o Rajesh Sharma R/o House No. 132 Sector 5 Nanak Nagar, Jammu under Application No. 6789571285 , Roll No. 181262416534 was among others, appointed to the post of Road Worker vide Government order No. 329-PW(R&B) of 2021 dated 24.10.2021 ; and

Whereas, vide Government order No. 329-PW(R&B) of 2021 dated 24.10.2021, among others, the services of Shri Sahil Sharma were placed at the disposal of the Chief Engineer, PW(R&B) Department Jammu for further posting;

Whereas, while being posted in the Chief Engineer, PW(R&B) Department, Jammu, Shri Sahil Sharma, joined on 13.11.2021 and posted in PWD(R&B) Construction Division No. II Jammu vide office order No. CEJ/ADM/320 of 2021 dated 16.11.2021 by the Chief Engineer; and

Whereas, subsequent to his appointment, the Chief Engineer, PW(R&B) Department Jammu vide letter No. CE/Estab/S/2407-08 dated 14.12.2021 reported that the official has tendered his resignation in the Public Works (R&B) Department before Executive Engineer, Division No. II, Jammu on 30.11.2021 on the grounds that it is not possible for him to continue his higher studies along with the government job;

Whereas, the Chief Engineer, PW(R&B) Department, Jammu forwarded his request to the Public Works (R&B) Department for acceptance of his resignation;

Whereas, the matter has been considered with reference to the rules governing the subject and it has been found that the official is still on probation and has not qualified the prescribed service.

Now, therefore, in exercise of the powers conferred under Rule 22(1) (b) of the J&K Civil Services (Classification, Control & Appeal) Rules, 1956, the resignation tendered by Shri Sahil Sharma, Road Worker is hereby accepted and he is discharged from the service w.e.f. 30.11.2021, on his request.
