Whereas, Shri Ansar Amin Raina, Works Supervisor of R&B Division Vailoo was placed under suspension vide Government order No. 265-PW(R&B) of 2021 dated 08.9.2021; and

Whereas, vide Government order No. 306-PW(R&B) of 2021 dated 12.10.2021, Mr. Abdul Rashid Lone I/C Superintending Engineer, Public Works (R&B) Circle Anantnag-Kulgam was appointed as an inquiry officer to inquire into the charges served to Mr. Ansar Amin Raina, Works Supervisor, (R&B) Division Vailoo vide No. PWD-NGAZOCIV/50/2021-05 dated 05.10.2021 and directed to submit report within a period of 15 days; and

Whereas, the Superintending Engineer (Inquiry officer) PWD (R&B) Circle Anantnag-Kulgam vide communication No. 9216-17 dated 26.11.2021 submitted the inquiry report in the matter; and

Whereas, the suspension case of Mr. Ansar Amin Raina, Works Supervisor was placed before the Departmental Review Committee held under the Chairmanship of the Principal Secretary to the Government, Public Works (R&B) Department on 22.12.2021 at 03:00 PM for re-viewing the suspension of the official; and

Whereas, the Review Committee accepted the report of the inquiry officer and recommended to re-instate the official and his intervening period of suspension with effect from 08.9.2021 till date to be treated as on duty.

Now, therefore, sanction is hereby accorded to the reinstatement of Mr. Ansar Amin Raina, Works Supervisor (R&B) Division Vailoo placed under suspension vide Government order No. 265-PW(R&B) of 2021 dated 08.9.2021 with immediate effect. The intervening period of suspension of the official with effect from 08.9.2021 till date is treated as on duty and the official is warned to remain careful in future. He shall accordingly report to the Chief Engineer, PW(R&B) Kashmir for posting and further duties.
