Subject: Resignation of Shahid Afzal Thoker S/o Mohammad Afzal Thoker appointed as Junior Assistant.

Whereas, on the recommendations of the Services Selection Board, J&K conveyed vide No. JKSSB-PLAN/25/2022-03 dated 03.03.2023, among others, Shri Shahid Afzal Thoker was appointed as Junior Assistant vide Government Order No. 251-PW(R&B) of 2023 dated 13.06.2023; and

Whereas, among others, the services of Shri Shahid Afzal Thoker, Junior Assistant were placed at the disposal of the Chief Engineer, PW(R&B) Department, Kashmir for further posting; and

Whereas, subsequent to his appointment/joining, the Chief Engineer, PW(R&B) Department, South Kashmir vide communication No. CE/RBK/SK/ADM/457-59 dated 18.10.2023 has intimated that Shri Shahid Afzal S/o Mohammad Afzal Thoker, appointed as Junior Assistant has tendered resignation from Government Services through an application dated 18.09.2023, with the reason that he has been appointed as Junior Statistical Assistant vide Director General Economics and Statistics J&K's order No 254-DES of 2023 dated 16.09.2023; and

Whereas, the matter has been examined/considered with reference to the rules governing the subject and it has been observed that the concerned official is still on probation and has not qualified the prescribed probation period of service; and

Whereas, Rule 21(1) of J&K Civil Services (Classification, Control & Appeal), Rules, 1956, provides as under:-

"At any time before the expiry of prescribed period of probation the appointing authority may:

- suspend the probation of a probationer and discharge him from the service for want of vacancy; and
- at its discretion terminate the probation of a probationer and discharge him from the service."

Now, therefore, in exercise of the powers conferred under Rule 21 (1) (b) of the J&K Civil Services (Classification, Control & Appeal) Rules, 1956, the resignation tendered by Shri Shahid Afzal Thoker S/o Mohammad Afzal Thoker is hereby accepted and is discharged from the Government service w.e.f. 18.09.2023 on his own request.
