Whereas, on the recommendations of the Services Selection Board, J&K conveyed vide No. SSB/Secy/Sel/Class-IV/2021/7103-11 dated 18.10.2021 and General Administration Department's O.M. No. GAD/MTGRBIV/63/2021-09-GAD dated 19.10.2021, Smt. Sunakshi D/o Ajay Kumar R/o 68, 6 Arnia Jammu under Application No. 426264804 Roll No. 181266149025 was among others, appointed to the post of Road Worker vide Government order No. 329-PW(R&B) of 2021 dated 24.10.2021 ; and

Whereas, vide Government order No. 329-PW(R&B) of 2021 dated 24.10.2021, among others, the services of Smt. Sunakshi were placed at the disposal of the Chief Engineer, PW(R&B) Department Jammu for further posting; and

Whereas, while being posted in the office of the Chief Engineer, PW(R&B) Department, Jammu, Smt. Sunakshi joined on 01.11.2021 and posted in PWD(R&B) Construction Division No. I Jammu vide office order No. CEJ/ADM/320 of 2021 dated 16.11.2021 by the Chief Engineer; and

Whereas, subsequent to her appointment, the Chief Engineer, PW(R&B) Department Jammu vide letter No. CE/Estab/S/2273-75 dated 27.12.2021 reported that the official has tendered her resignation in the Public Works (R&B) Department before Executive Engineer, Division No. I, Jammu on 15.12.2021 on the grounds that she is not interested in the job of Road Worker; and

Whereas, the Chief Engineer, PW(R&B) Department, Jammu forwarded her request to the Public Works (R&B) Department for acceptance of her resignation;

Whereas, the matter has been considered with reference to the rules governing the subject and it has been found that the official is still on probation and has not qualified the prescribed service, therefore, in exercise of the powers conferred under Rule 22(1) (b) of the J&K Civil Services (Classification, Control & Appeal) Rules, 1956, the resignation tendered by Smt. Sunakshi, Road Worker is hereby accepted and she is discharged from the service w.e.f. 15.12.2021 on her request.
