The concerned Engineer shall submit an undertaking to the effect that he shall not extend his leave beyond specified period under any circumstances and shall not take part in any employment/ assignment either full time or part time basis including private profession, practice and consultancy etc, in the foreign country during his foreign visit.
4. The concerned engineer shall not take part in any such activity which is against the employee Conduct Rules.
5. The Concerned DDO shall enter the foreign visit and earned leave period in the Service book of the concerned Engineer.
