Subject: Cancellation of appointment order for the post of Class- IV, advertised vide Notification No. 01 of 2020 dated 26.06.2020.

Reference: No. CE/M&HD/K/Adm/4851-54 dated: 08/01/2024 from the Mechanical and Hospitals Engineering Department.

Whereas, on the recommendation of the Services Selection Board, J&K conveyed vide No. JKSSB-SD/38/2022-06 dated: 13/03/2023(E-7094885) duly endorsed by the General Administration Department vide O.M.No. GAD/MTG0RBIV/01/2023 dated: 09/06/2023, among others, Mr. Bashir Ul Haq S/o Bashir Ahmad Dar was appointed Class IV (MTS) vide Government Order No. 268-PW(R&B) of 2023 dated 23.06.2023 issued by the Public Works(R&B) Department, on the basis of provisional character and Antecedents certificate forwarded by the Deputy Commissioner Kulgam vide No. DCK/Verification/class-iv/2022-23/388 dated 28.10.2022, subject to, among other conditions that the clearance received from the District Magistrate Kulgam is provisional and it shall be mandatory for the appointee to fill in verification Rolls (V-Rolls) as available through the online mode under the Electronic Employment Verification System(EVS); and

Whereas, subsequent to his appointment, the appointee was directed to report to the Chief Engineer, Mechanical Engineering Department, Kashmir within a period of 21 days from the date of issuance of appointment order, failing which the appointment shall be deemed to have been cancelled ab-initio without any notice and joined there on 27.06.2023;and

Whereas, the Chief Engineer, Mechanical and Hospitals Engineering Department Kashmir vide communication No. CE/M&HD/K/Adm/4851-54 dated: 08/01/2024 forwarded the case of Mr. Bashir Ul Haq, in whose favour the security clearance was denied vide Form No. 67581 dated: 03/11/2023, which revealed that the concerned security agency held that:-

"Case Not Recommended by review Committee in a meeting held on 19.10.2023. Hence, security clearance may be denied" ;and

Whereas, the case of the appointee got examined and subsequently, referred to the Home Department for placing before the designated Screening Committee constituted for the purpose vide Government Order No. 958-JK(GAD) of 2021 dated: 16/09/2021; and

Whereas, as per minutes of the meeting of the Screening Committee held on 18-03-2024 endorsed by the Home Department vide O.M No Home-ISA/161/2023-05-Home (7163790) dated 29-03-2024, the committee has taken the following decision in the case:

"The Screening Committee has examined the case in details related to Mr. Bashir UI Haq, who has been selected/appointed as MTS in Public Works (R&B) Department. It was observed by the said Committee that the candidate has already been appointed by the Department on the basis of the provisional report obtained from CID Agency by the District Magistrate, Kulgam. The Committee noted that subsequently when the detailed verification was conducted by the CID, the case of Mr. Bashir UI Haq, was not cleared by the CID. After detailed deliberation in the matter, it was decided that in view of security clearance having been denied by the CID, the Public Works (R&B) Department should take immediate steps to cancel the appointment order issued in favour of Mr. Bashir UI Haq."

Now, therefore, in light of the aforementioned decision of the UT Level Screening Committee, it is hereby ordered that the appointment of Mr. Bashir UI Haq, MTS under EWS category in the Public Works (R&B) Department appointed vide Government Order No 268-PW(R&B) of 2023 dated 23.06.2023 is hereby cancelled ab-initio.
