Sanction is hereby accorded to the grant of permission to visit outside country in favour Er. Mushtaq Ahmad Bhat, Assistant Engineer (Mech), Irrigation Sub-Division Baramulla, for performing Umrah in Saudi Arabia for a period of 38 days w.e.f. 07.01.2025 to 13.02.2025, subject to the following conditions:

1. That the Earned Leave shall be sanctioned by the concerned HOD for the specified period of visit and the concerned DDO shall enter the foreign visit and leave in Service book of the concerned officer.
2. The Chief Engineer shall assign charge of the post to any other officer during the leave period.
3. The concerned Engineer shall submit an Affidavit to the effect that he shall not extend his leave beyond specified period under any circumstances and shall not take part in any employment/ assignment either full time or part time basis including private profession, practice and consultancy etc. in the foreign country during his visit.
4. The concerned engineer shall stick to the specified dates and leave shall not be extended beyond the specified date.
5. The concerned engineer shall not take part in any such activity which is unbecoming of a Government servant.
