Sanction is hereby accorded to the delegation of Drawing & Disbursing Powers in favour of Superintending Engineer, (R&B) Circle, Pulwama-Shopian for operating the funds placed at his disposal under Major Heads:2059-Public works, 2211-Housing, 4059-COOP, 5054-Captial (Outlay), 2071-PORB/NPS, 3054-R&B, 8009-GP Fund, 8011-SLI & remittance thereof, operating upon District Treasury Pulwama.

The DDO Powers are subject to the following conditions:-

- a) That he shall operate on the treasury to the extent funds are placed at his disposal by the competent authority.
- b) That all the codal formalities should be fulfilled while incurring the expenditure.
- c) That no excess over allotment/irregular expenditure is made by the DDO.
- d) That the concerned DDO shall ensure submission of the Accounts to the different quarters in time and maintain record as prescribed under rules.
- e) That the DDO shall submit the monthly Receipt/Expenditure statement to the Administrative Department through their controlling Officer.
- f) DDO shall also obtain A.G's Code from the Accountant General, J&K.


