**Govt. Order No. 140 -PW(R&B) of 2022
Dated: 20 -04-2022.**

Sanction is hereby accorded to the extension of Drawing & Disbursing Powers in favour of the Gulmarg Development Authority Tangmarg of (R&B) Sub Division Magam in respect of Revenue Expenditure and Capital Expenditure for a further period of one year w.e.f 01-04-2022 to 31-03-2023 or date of its abolition or change of nomenclature/ withdrawal of Drawing & Disbursing Powers whichever earlier. The DDO powers delegated to the officer are governed by Govt. Order No. 100-F of 2016 dated 30/03/2016. The Executive Engineer concerned shall operate the funds placed at his disposal by the Controlling officer/Competent authority upon the Treasury Tangmarg.

The DDO powers are extended subject to fulfillment of following conditions.

- That he shall operate on the treasury to the extend funds are placed at his disposal by the competent authority.
- That all the codal formalities should be fulfilled while incurring the expenditure.
- That no excess over allotment/irregular expenditure is made by the DDO.
- That the concerned DDO shall ensure submission of the Accounts to the different quarter in time.
- That the DDO shall submit the monthly Receipt/Expenditure statement to the Administrative Department through their controlling Officer.
