Subject: Resignation of Sh. Waseem Akram appointed as Junior Assistant.

Reference: CECV/01-02 dated: 01.04.2024 from the Chief Engineer, Chenab Zone Batote.

Whereas, on the recommendations of the Services Selection Board, J&K conveyed vide communication No JKSSB-PLAN/25/2022-03 dated 03.03.2023, among others, Sh. Waseem Akram was appointed as Junior Assistant vide Government order No. 200-PW(R&B) of 2023 dated 18.05.2023 ; and

Whereas, among others, the services of Sh. Waseem Akram, Junior Assistant were placed at the disposal of the Chief Engineer, PW(R&B) Department Jammu for further posting; and

Whereas, subsequent to his appointment/ joining, the Chief Engineer PW(R&B) Department Chenab Zone Batote vide letter No. CECV/01-02 dated: 01.04.2024 has intimated that Sh. Waseem Akram appointed as Junior Assistant has tendered resignation from Government Services through an application dated: 09/03/2024 on the grounds that he has been appointed as Sub Inspector in J&K Police Department; and

Whereas, the matter has been examined/considered with reference to the rules governing the subject and it has been observed that the concerned official is still on probation and has not qualified the prescribed probation period of service; and

Whereas, Rule 21(1) of J&K Civil Services (Classification, Control & Appeal), Rules, 1956, provides as under:-

"At any time before the expiry of prescribed period of probation the appointing authority may:

- e. suspend the probation of a probationer and discharge him from the service for want of vacancy; and
- f. at its discretion terminate the probation of a probationer and discharge him from the service."

Now, therefore, in exercise of the powers conferred under Rule 21(1) (b) of the J&K Civil Services (Classification, Control & Appeal) Rules, 1956, the resignation tendered by Sh. Waseem Akram is hereby accepted and is discharged from the Government service w.e.f. 09.03.2024 on his own request.
