Subject: Re-instatement of Er. Rayees Ahmad Runyal, Manager (Assistant Engineer) JKPCC Unit Jammu.

Whereas, Er. Rayees Ahmed Runyal (AE) Manager, JKPCC was placed under suspension by Executive Director, JKPCC for poor punctuality, lack of proper command and control for supervision of sites on 02-08-2022 and was attached with the office of Director General Manager, Unit Jammu.

Whereas, the delinquent Engineer, approached the Administrative Department with the request to consider his case and to reinstate him. The case of the said Engineer was examined in the department and consequently, vide Government Order No.26-PW(R&B) of 2023 dated 12.01.2023, Er. Sanjeev Gupta, I/c Superintending Engineer, JDA and Er. Sajad Khan, I/c Assistant Executive Engineer, R&B, Construction Division 3rd Jammu were appointed as Inquiry Officer and Presenting Officer.

Whereas the Inquiry Officer submitted his report vide communication No.SE/JDA/2023/2637-45 dated: 30.01.2023 and reported that:

1. Er. Rayees Ahmed, Assistant Engineer was posted as Assistant Engineer in JKPCC vide Government Order No.156-PW(R&B) of 2022 dated: 07.05.2022 and joined in the JKPCC, Ltd.on 17-05-2022.
2. He was allotted work of Construction of Institute of Drivers and Training Research, Jammu, Kot Bhalwal and Revenue Complex, Gole Gujral Talab Tillo, Jammu.
3. During the day of inspection of the site in question (Construction of Institute of Drivers and Training Research, Jammu by Managing Director the work was not in progress as the allotment order has been issued on 26-08-2022 vide No.GM/J/658-61 after TA and AA.
4. The work of Construction of Revenue Institute Training at Gole Gujral Jammu was allotted to Rayees Runyal on 01-06-2022 after financial and Technical assessment on the work in question was allotted to the contractor on 28-6-2022. The bill or said work was submitted to DGM, JKPCC on 01-8-2022 amounting to Rs.707297/- and Rs, 1307588/- and stands recorded in the as M book.

Whereas, the Inquiry Officer recommended dropping of all charges and reinstating the delinquent engineer as the charges could not be proved.

Whereas, the case referred to Development Commissioner (Works) for comments and he returned the case with the remarks that two and half months is short period to judge the performance of an officer in a new organization and recommended upholding the report of I.O and reinstating the officer with an advice to remain careful. The instant case has been examined in the department ,it was observed that there is no vigilance angle in the instant case and the I.O has justified that the work in question was already in progress and two and half period is actually too short to judge he performance of a field officer , and his performance on EPM for the months Feb -July 2022 is very good with average grading of 8.00 even for the months he was in JKPCCL i.e June –July, 2022.

Whereas, the MD , JKPCCL vide PS/MD/5/52-56 dated 24.03.2023 also recommended reinstatement of Rayees Runyal and suspension period to be treated as duty.

Whereas, the case was submitted to the competent authority for decision, the Competent Authority accepted the findings of Inquiry Officer, DCW and MD JKPCCL Ltd.

Now, therefore, in view of the above and by upholding he recommendation of Inquiry Officer, Managing Director, J&K PCC Ltd and Development Commissioner(Works), with the approval of Competent Authority, the allegations levelled against Er. Rayees Ahmed Runyal, Manager/AE(Civil), JKPCCL are dropped and is hereby re-instated with immediate effect .
