In case any candidate fail to join within the stipulated period, his/her appointment shall be deemed to have been cancelled ab-initio without any Notice.

The appointees shall be allowed to join after production of the following certificates/documents (in original) to be verified subsequently:-

- i. Educational/Technical Qualification Degree (Degree Certificate) issued by the recognized Institute/University valid for employment.
- ii. Matriculation/ Date of Birth Certificate.
- iii. Domicile Certificate issued by the Competent Authority.
- iv. Health Certificate from the concerned District Chief Medical Officer.
- v. Certificate from the District Industries Centre (DIC) and District Employment and Counseling Centre to the effect that no loan under any self employment scheme has been availed by the candidate.
- vi. Valid relevant category certificate, if any applicable.

Besides, the appointment of the above candidates shall further be subject to the following conditions:

- a) The appointee shall furnish an undertaking in the shape of an affidavit to the effect that the appointee has no any criminal records and also not facing any criminal proceedings in any Court of law.
- b) The salary of the appointee shall not be drawn and disburse to them unless satisfactory report in respect of genuineness of their qualification/degree certificate/Date of Birth/relevant category certificate is received from the concerned issuing authority.
- c) The appointment of the candidate shall be governed in terms of Jammu & Kashmir Probationer (Condition of Service, Pay and Allowances) and Fixation of Tenure Rules, 2020 notified vide S.O. 192 of 2020 dated 17.06.2020.
- d) The inter-se-seniority of the appointees shall be determined in accordance with the merit secured by the appointee in the selection list prepared by the J&K Public Service Commission.
