Whereas, the Chief Engineer, PMGSY (JKRRDA), Kashmir vide his letter No. CE/ PMGSY/ K/ Estab./ 4889-91 dated 06.10.2021 has forwarded the case of Mr.Javed Ahmad Dar, Draftsman (Civil) whose particulars are given below for acceptance of his diploma in Civil Engineering and inclusion of his name in the seniority list of Diploma Holders Draftsman (Civil):-

Whereas, the case was examined in this department and marks/diploma certificates of the above named official were forwarded to the Secretary J&K State Board of Technical Education, J&K vide letter dated 19.01.2022 for verification/ authentication of genuineness of the diploma/ marks certificates acquired by the official. In response, the Secretary, J&K, Board of Technical Education vide his letter No. BOTE/ Verif/ 22/ Dated /01 /2022 has verified the diploma/ marks certificates of the official.

Whereas, the above named incumbent has also produced undertakings in the shape of Affidavit dully attested by the Sub Judge Special Mobile Magistrate Anantnag affirming therein that in case, the diploma certificate issued by the State Board of Technical Education department is found fraudulent/bogus at any time during service, the same shall be deemed to be cancelled abi-initio and action as warranted under rules shall be initiated against me in terms of J&K Civil Service rules.

Whereas, the case was re-examined in the department and it has been decided to accept the Diploma certificates acquired by the above named official, treat him as Diploma holder Draftsman (Civil) and include his name at appropriate place in the relevant seniority list of Diploma holders Draftsman (Civil) and also exclusion of his name from the relevant seniority list wherever exists.

Whereas, a notice was issued vide dated 15.03.2021 for inviting therein objections from the members of the cadre who are likely to be affected due to decision of the department. In response, the Chief Engineer, PMGSY (JKRRDA), Kashmir vide his letter No. CE/ PMGSY/ K/ Estab/ 801-03 dated 21.04.2022 has intimated that no objection regarding the matter have been received by his office till date.

Now therefore, Mr.Javed Ahmad Dar, Draftsman (Civil) shall henceforth be treated as Diploma holder Draftsman (Civil) and subsequently his name shall be included at appropriate place in the relevant seniority list of Diploma Holders Draftsman (Civil) as and when the same is notified afresh by the Department, consequently his name shall be deemed to be delete from the seniority list wherever exists.
