Whereas, on the recommendations of the Services Selection Board, J&K, conveyed vide communication No. SSB/Secy/Sel/Class- IV/2021/6273-78 dated 18.10.2022 duly endorsed by the General Administration Department vide O.M. No. GAD/MTGRDIV/267/2022-09-GAD dated 27.10.2022, among others, Mr. Sahil Kumar was appointed as Class IV (MTS), vide Government Order No. 337- PW(R&B) of 2021 dated 03.11.2021; and

Whereas, vide Government Order No.337-PW(R&B) of 2021 dated 03.11.2021, among others, the services of Mr. Sahil Kumar (MTS) , Road worker were placed at the disposal of the Chief Engineer, PW(R&B) Department, Jammu, for further posting; and

Whereas, subsequent to his appointment and joining, the Chief Engineer, PW(R&B) Department, Jammu, vide his letter No. CEJ/Estab/s/3489-91 dated 26.03.2024 informed that Mr. Sahil Kumar (MTS), Road worker, through the medium of an application dated 09.03.2024, has tendered resignation from the post of Class-IV (MTS); and

Whereas, the Chief Engineer, PW(R&B) Department, Jammu, forwarded his case to this Department for acceptance of his resignation on the grounds that the said candidate has been appointed as Junior Engineer(Civil) in Public Works (R&B) Department, vide Government Order No. 61-PW(R&B) of 2024 dated 07.03.2024; and

Whereas, the matter has been examined/ considered with reference to the rules governing the subject and it has been observed that the concerned official is still on probation and has not qualified the prescribed probation period of service; and

Whereas, Rule 21(1) of J&K Civil Services (Classification, Control & Appeal), Rules, 1956, provides as under:-

"At any time before the expiry of prescribed period of probation the appointing authority may:

- a. suspend the probation of a probationer and discharge him from the service for want of vacancy; and
- at its discretion terminate the probation of a probationer and discharge him from the service.

Now, therefore, in exercise of the powers conferred under Rule 21(1) (b) of the J&K Civil Services (Classification, Control & Appeal) Rules, 1956, the resignation tendered by Mr. Sahil Kumar, Class-IV (MTS), is hereby accepted and he is discharged from the Government service w.e.f. 09.03.2024 on his own request.
