Whereas, Mr. Arun Singh was appointed as Junior Assistant under Prime Minister's Special Employment Package in District Kulgam vide Order No. K-57(ADM) of 2020 dated 11.09.2020 issued by the Chief Engineer, PW(R&B) Department Kashmir's in pursuance of this department's communication No. PW(R&B) NG/21/2020 dated 21.07.2020; and

Whereas, the Superintending Engineer (R&B) Circle Anantnag-Kulgam forwarded an application dated 06.04.2022 of the said Junior Assistant, who has tendered resignation from the post of Junior Assistant w.e.f. 06.04.2022 due to his appointment as Assistant Compiler in J&K Funds Organization vide Order No. 43-DGF of 2022 dated 24.03.2022; and

Whereas, the Chief Engineer, PW(R&B) Department Kashmir recommended the instant case and forwarded to the Administrative Department PW(R&B) in original for further necessary action; and

Whereas, the case of resignation tendered by Mr Arun Singh Junior Assistant got examined in the department in light of Rule 21 (1) of Jammu and Kashmir Civil Services (Classification Control and Appeal) Rules, 1956 which reads as under:-

- 21(1) At any time before the expiry of the prescribed period of probation, the appointing authority may:**
- (a) suspend the probation of a probationer and discharge him from the service for want of vacancy; and**
  - (b) at its discretion terminate the probation of a probationer and discharge him from the service.**

Now, the matter has been considered with reference to the rules governing the subject and it has been found that the official is still on probation and has not qualified the prescribed service, therefore, in exercise of the powers conferred under Rule 21(1) (a) (b) of the J&K Civil Services (Classification, Control & Appeal) Rules, 1956, the resignation tendered by Mr. Arun Singh Junior Assistant appointed under Hon'ble PM special employment package in district Kulgam is hereby accepted w.e.f. 06.04.2022.
