Whereas, on the recommendations of the Services Selection Board, J&K conveyed vide No. SSB/Secy/Sel/Class-IV/2021/7103-11 dated 18.10.2021 and the General Administration Department's OM No. GAD/MTGRBIV/63/2021-09-GAD dated 19.10.2021, Mr. Jamshid Bashir S/o Bashir Ahmad R/o Ward No. 3 Bahadurkote Kupwara under PSP category, Application No. 8171655045 & Roll No. 211374462282 Divisional Cadre Kashmir was among others, appointed to the post of Chowkidar vide Government order No. 79-PW(R&B) of 2022 dated 28.02.2022; and

Whereas, vide Government order No. 79-PW(R&B) of 2022 dated 28.02.2022, among others, the services of Mr. Jamshid Bashir were placed at the disposal of the Chief Engineer, PW(R&B) Department Kashmir for further posting; and

Whereas, while being posted in the office of the Chief Engineer, PW(R&B) Department, Kashmir Mr. Jamshid Bashir joined Government service on 12.03.2022 and posted in R&B Division Handwara vide office order No. K-202(ADM) of 2022 dated 19.03.2022 by the Chief Engineer; and

Whereas, subsequent to his appointment, the Chief Engineer, PW(R&B) Department Kashmir vide letter No. CE/RBK/ADM/3941-42 dated 12.05.2022 reported that the official has tendered his resignation in the Public Works (R&B) Department before Executive Engineer, (R&B) Division Handwara on 12.04.2022 on the grounds that he has been continuing his further studies; and



Whereas, the Chief Engineer, PW(R&B) Department, Kashmir forwarded his request to the Public Works (R&B) Department for acceptance of his resignation w.e.f. 12.04.2022.

Now, the matter has been considered with reference to the rules governing the subject and it has been found that the official is still on probation and has not qualified the prescribed service, therefore, in exercise of the powers conferred under Rule 22(1) (b) of the J&K Civil Services (Classification, Control & Appeal) Rules, 1956, the resignation tendered by Mr. Jamshid Bashir S/o Bashir Ahmad R/o Ward No. 3 Bahadurkote Kupwara under PSP category is hereby accepted and he is discharged from the service w.e.f. 12.04.2022.
