- The Technical sanction/administrative approval shall be obtained prior for undertaking the said work from the competent authority.
- The expenditure shall be incurred strictly as per the guidelines of the scheme and conditions laid down in the sanctioned letter of the concerned Ministry, Govt. of India The Expenditure on this account shall be debited to the detailed account head given as under: -
