WHEREAS, the Chief Engineer, PW(R&B) Department, Central Kashmir, vide communication No. CE/R&B/CK/ADM/9700-9702 dated 11.03.2024 intimated that Ms. Lylooma Wani, Junior Engineer, has been appointed against a post in the Junior Scale of the Jammu & Kashmir Administrative Service, vide Government Order No. 225- JK(GAD) of 2024 dated 25.01.2024;

AND WHEREAS, the Chief Engineer, PW(R&B) Department, Central Kashmir recommended the case of Ms. Lylooma Wani for acceptance of her technical resignation tendered from the post of Junior Engineer (Civil) w.e.f. 05.02.2024;

AND WHEREAS, the case of Ms Lylooma Wani Junior Engineer was examined in the Department and it was found that she has been appointed as Junior Engineer vide Government order No. 173-PW(R&B) of 2016 dated 25.05.2016 in the Public Works (R&B) Department and is presently working in the Project Construction 1st High Court Sub Division PW(R&B) Department, Srinagar;

AND WHEREAS, from records, it has been found that Ms. Lylooma Wani, Junior Engineer had applied for appearing in the Combined Competitive Examination, conducted by the J&K Public Service Commission, through proper channel;

AND WHEREAS, Article-201 J&K CSR Vol-I states that " Resignation of an appointment to take up another appointment in which service counts, is not to be held to be a resignation of the Government Service, provided the consent of the former departmental superior is obtained to accepting, such employment";

Now, therefore, in terms of Article-201 of J&K CSR Vol-I, the technical resignation tendered by Ms. Lylooma Wani, Junior Engineer (civil), is hereby accepted with effect from 05.02.2024. The official shall obtain No Dues Certificate from the concerned offices in due course of time.
