As recommended by the J&K Public Service Commission, sanction is hereby accorded to the temporary appointment of Mr. Aaqib Mehraj, S/o Mehraj U Din, R/o 48/F Patlipora Bala Chattabal Srinagar having secured 43.71 points under EWS Category as Assistant Engineer (Mechanical), UT Cadre, in the Pay Level-8A (50700-160600) in the Public Works (R&B) Department in EWS Category, in whose favour, the positive verification report has been received from the Criminal Investigation Department vide form No. 103348 dated 19.06.2024.

The appointee shall report to Secretary to the Government, Public Works Department, Civil Secretariat, Srinagar within a period of twenty one (21) days from the date of issuance of this Order. In case he fails to join within the stipulated period, his appointment shall be deemed to have been cancelled without any Notice.

The appointee shall be allowed to join only after production of the following certificates/documents (in original) to be verified subsequently:-

1. Educational/Technical Qualification Degree (Degree Certificate) issued by the recognized Institute/University valid for employment.
2. Matriculation/ Date of Birth Certificate duly recognized by the competent authority.
3. Domicile Certificate issued by the Competent Authority
4. Health Certificate from the concerned District Chief Medical Officer.
5. Valid relevant category certificate.
6. That if the candidate has taken loan for self employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counseling Centre of the domicile District, he shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self employment unit/enterprise before joining the Government service. He shall be required to repay the entire loan liability/in suitable EMIs to be worked out by the DDO concerned from his salary, DDO concerned shall obtain an affidavit

from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self employment unit/enterprise and recovery to be made and also personally monitor its recovery in terms of Circular No. 06-JK(GAD) of 2023 dated 06.02.2023 issued by the General Administration Department.

The appointment of the above candidate shall further be subject to the following conditions:-

- a. The appointee shall furnish an undertaking in the shape of an Affidavit to the effect that the appointee has no any criminal records and also not facing any criminal proceedings in any Court of law.
- b. The salary of the appointee shall not be drawn and disbursed to him unless satisfactory report in respect of genuineness of his qualification/degree certificate/Date of birth/relevant category certificate is received from the concerned issuing authority.
- c. The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.
- d. The appointee shall be on probation for a period of 02 years.
- e. The inter-se-seniority of the appointee shall be determined in accordance with the merit secured by the appointee in the selection list prepared by the J&K Public Service Commission.
- f. The appointment of the above candidate shall be subject to outcome of writ petition(s), if any, pending before any Competent Court of Law.


