Whereas, the Chief Engineer, PW(R&B) Kashmir vide his letter No. CE/RBK/ADM/3102-03 dated 02.05.2023 has forwarded the case of Mr. Zahid Ahmad Bhat, Draftsman (Civil) alongwith allied documents for accepting of his diploma and inclusion of his name in the relevant seniority list of Draftsman (Civil). Whereas, the case was examined in this department and marks/diploma certificates of the above named official were forwarded to the Registrar, Islamic university of Science & Technology, Awantipora Kashmir vide this department's letter dated 18.05.2022 for verification/authentication & genuineness of the diploma/marks certificates. In response, the Controller of Examination, Islamic University of Science & Technology, Awantipora vide communication No. IUST/Exam-Unit/Verification/22/533 dated 25.05.2022 has verified the diploma certificate of the incumbent.

Whereas, the above named incumbent has also produced undertaking in the shape of Affidavit affirming therein that in case the diploma certificate issued by Islamic University of Science & Technology Awantipora is found fraudulent bogus at any time during service, the same shall be deemed to be canceled ab-initio and action as warranted under rules shall be initiated against him in terms of J&K Civil Service Rules.

Whereas, a notice was issued vide No. PWD-HRM1/104/2022-05 dated 22.06.2022 for inviting therein objections from the members of the cadre who are likely to be affected due to decision of the department. In response, the Chief Engineer PW(R&B) Kashmir vide his letter No. CE/ RBK/ ADM/ 15425-26 dated 10.08.2022 has intimated that no objection has been received by his office in this regard, however, during examination of the case in the department, it was found that paper cutting of relevant newspaper was not attached with the case.

Whereas, vide this department's letter dated 19.09.2022 the Chief Engineer R&B Kashmir was asked to furnish the news paper cutting of relevant two leading newspaper/s (each one from Srinagar/Jammu), whereunder the requisite notice was published. In response, the Chief Engineer R&B Kashmir vide letter dated 06.03.2023 has furnished paper cutting of relevant newspapers to this department.

Whereas, the case has been re-examined in the department and it has been decided to accept the Diploma certificate acquired by the above named official, treat him as Diploma holder Draftsman (Civil).

Now therefore, Mr. Zahid Ahmad Bhat, Draftsman (Civil) shall henceforth be treated as Diploma holder Draftsman (Civil) and subsequently his name shall be included at appropriate place in the relevant seniority list of Diploma holders Draftsman (Civil) as and when the same is notified afresh by the department.
