WHEREAS, on the recommendations of the Services Selection Board, J&K conveyed vide No. SSB/Secy/Sel/Class- IV/2021/6273-78 dated 18.10.2022 duly endorsed by the General Administration Department's vide O.M. No. GAD/MTGRDIV/267/2022-09-GAD dated 27.10.2022, among others, Shri Shahid Rashid (MTS) was appointed as Class IV (MTS) vide Government order No. 317-PW(R&B) of 2021 dated: 22/10/2021;

AND WHEREAS vide Government order No. Govt Order No. 317- PW(R&B) of 2021 dated: 22/10/2021, among others, the services of Shri Shahid Rashid (MTS), Road worker were placed at the disposal of the Chief Engineer, PW(R&B) Kashmir for further posting, who has joined there;

AND WHEREAS, the Chief Engineer, PW(R&B) South Kashmir forwarded his request to the Public Works (R&B) Department for acceptance of his resignation as the said candidate has been appointed as Junior Engineer (Civil) vide Government Order No. 61-PW(R&B) of 2024 dated: 07/03/2024.

AND WHEREAS, the matter has been examined/considered with reference to the rules governing the subject and it has been observed that the concerned official is still on probation and has not qualified the prescribed probation period of service.

AND WHEREAS , Rule 21(1) of J&K Civil Services (Classification, Control & Appeal), Rules, 1956, provides as under:-

At any time before the expiry of prescribed period of probation the appointing authority may:

a. suspend the probation of a probationer and discharge him from the service for want of vacancy; and

b. at its discretion terminate the probation of a probationer and discharge him from the service."

Now, therefore, in exercise of the powers conferred under Rule 21(1) (b) of the J&K Civil Services (Classification, Control & Appeal) Rules, 1956, the resignation tendered by Mr. Shahid Rashid, Class-IV (MTS) is hereby accepted and is discharged from the Government service w.e.f. 07.03.2024 on his own request.
