Whereas, the Chief Engineer R&B Jammu vide his letter dated 24.08.2022 has forwarded the case of Sh. Sachin Kumar, Draftsman for acceptance of his three years Diploma In Civil Engineering and inclusion of his name in the seniority list of Draftsman (Civil). The particulars of the said Draftsman are as under:-

Whereas, the case was examined in the department and copies of Diploma/ marks certificates of the above named Draftsman were forwarded to the concerned Institution vide this department's letter dated 26.12.2022 for verification/ authenticate of genuineness of the Diploma acquired by the said Draftsman. In response the Registrar, Punjab State Board of Technical Education and Industrial Training vide their letter No. PSB/Verification/2023/404 dated 27.02.2023 has verified the diploma acquired by the above named candidate.

Whereas, the above named incumbent has also produced undertakings in the shape of Affidavit wherein he has intimated that in

case any information about his diploma certificate/marks certificate is found bogus at any time, during service, his diploma shall be deemed to be cancelled ab initio and action under the law or action as warranted under rules shall be taken against him in light of the J&K Civil Services (Classification Control, and appeal Rules-1956).

Whereas, the case was examined in the department and a notice was issued vide No. PWD-HRM1/248/2022-05 dated 28.03.2023 for inviting therein objections from the members of the cadre who are likely to be affected due to decision of the department & in response the Chief Engineer, PW(R&B), Jammu vide his letter No. CEJ/Estab./s/144-46 dated 04.05.2023 has intimated that his office has not received any objections from any person till date after issuance/publication of the notice.

Whereas, the case has been re-examined in the department and it has been decided to accept the Diploma certificates acquired by the above named official, treat him as Diploma holder Draftsman (Civil) and include his name at appropriate place in the relevant seniority list of Diploma holders Draftsman (Civil) as and when the same is updated/notified by the department.

Now, therefore, Sh. Sachin Kumar, Draftsman (Civil) shall henceforth be treated as Diploma holder Draftsman (Civil) and subsequently his name shall be included at appropriate place in the relevant seniority list of Diploma holders Draftsman (Civil) as and when the same is updated/ notified afresh by the department.
