On the recommendations of the J&K Services Selection Board and in continuation of Government Order No. 205-PW(R&B) of 2024 dated 25.07.2024, sanction is hereby accorded to the appointment of Ashak Hussain Dar S/o Gh. Nabi Dar, Roll No. 1039774, SL S.No. 37-OM, Selection Category OM/HCL against the post of Works Supervisor in the Pay Level SL-2 (15900-50400) in Divisional Cadre Kashmir under respective category, in whose favour the final satisfactory report of Character & Antecedents has been received from the Criminal Investigation Department, J&K notionally w.e.f. 30.05.2024 and monetarily with immediate effect.

Consequent upon the appointment, the appointee shall report to the office of the Chief Engineer PW(R&B), Central Kashmir within a period of twenty one (21) days from the date of issuance of this order. In case the candidate fails to join within the stipulated period, his appointment shall be deemed to have been cancelled ab-initio.

The appointee shall be allowed to join after production of the following certificates/documents (in original) to be verified separately:-

- Academic Qualification Certificates.
- Matriculation/Date of Birth Certificate issued by the recognized Education Board.
- Domicile certificate issued by the competent authority.
- Health Certificate from the concerned District Chief Medical Officer.
- Valid relevant category certificate issued by the competent authority, if any applicable.
- 6. That if the candidate has taken loan for self employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counseling Centre of the domicile District, he/she shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self-employment unit/enterprise before joining the Government service. He/she shall be required to repay the entire loan liability/in suitable EMIs to be worked out by the DDO concerned from his/her salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self-employment unit/enterprise and recovery to be made and also personally monitor its recovery in terms of Circular No. 06-JK(GAD) of 2023 dated 06.02.2023 issued by the General Administration Department.

- The appointment of the above candidate shall further be subject to the following conditions:-
- The appointee shall furnish an undertaking in the shape of an affidavit to the effect that the 1. appointee has no criminal record and is not facing any criminal proceedings in any court of law.
- If on verification of the qualification certificates/DOB and other documents from the concerned ij. issuing authority are proved fake/forged, the claim of the appointee for appointment shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against his/her.
- The salary of the appointee shall not be drawn and disbursed to him unless satisfactory report in III. respect of genuineness of his qualification/degree certificate/Date of Birth/Relevant Category Certificate is received from the concerned issuing authority.
- The appointment of the candidate shall be governed by the New Pension Scheme" as per SROiv. 400 of 2009 dated 24.12.2009.
- The appointee shall be on probation for a period of 02 years ٧.
- The inter-se-seniority of the appointee shall be determined in accordance with the merit secured vi. by the appointee in the selection list prepared by the Services Selection Board.
- The appointment of the above candidate shall be subject to outcome of writ petition(s), if any, vii. pending before any competent court of law.
