3	Construction of 150 mtr span double lane RCC motorable bridge with 1.2 mtr wide footpath on both side over Mandi Nallah at Sathra to Kanal, Tehsil Mandi District Poonch under NABARD	1193.94

The Administrative Approval is subject to the fulfillment of following conditions:-

- 1. The works shall be executed after observing all Codal /procedural formalities.*
- 2. The projects are designed as per latest relevant I.S. Codes and specifications of MoRTH/PWD Engineering Manual 2020/CPWD and as per J&K Bridge Manual. The same are authenticated and proof checked by the competent authority (NIT/DIQC) before taking up execution in hand.*
- 3. Rates for the items, not covered in JK SSR or any other relevant schedule, shall conform to Analysis of rates based on authentic Data Book, to be computed and approved by the competent authority well before invitation of tenders in accordance with set codal procedures.*
- 4. That the lump-sum provisions, either in terms of percentage or fixed, as made for certain components of each DPR are provisional and shall be subject to detailed estimates based on actual details/requirements and relevant rates,*

- to be framed and approved by competent authorities well before invitation of tenders in accordance with set codal procedures.
5. That the working BOQs, based on approved design details/requirements, are framed as per J&K PWD schedule of rates for e-tendering purpose of each project.
 6. The detailed estimate of works shall be technically sanctioned by the competent authority.
 7. It must be ensured that there shall be no multisource of funding or overlapping of schemes under different programmes.
 8. E-tendering mode is followed for fixation of the award of contract for execution of the projects. Fragmentation of project, while tendering, is not allowed.

The expenditure on this account shall be debit able to relevant account head.
