Sanction is accorded to the advance drawl for an amount of Rs.5.00 Crores (Rupees Five Crores) only, in favour of Chief Engineer, Mechanical Engineering Department, Kashmir, for procurement of 11 Numbers Snow Clearance Machines 4-Wheeled Drive 160 HP Trucks CAB Chasis with Load Body Fitted with Variable Snow Plough, subject to the following conditions:-

- i. Chief Engineer Mechanical Engineering Department, Kashmir shall be sure about the non availability of these vehicles on the GeM Portal.
- ii. The Purchase of vehicles shall be made after following all the required codal procedures as provided in GFR-2017.
- iii. No post of driver shall be created.
- iv. Accounts Officer (MED), shall vouchsafe the availability of the funds under Capex- 2021-22.
- v. The funds shall not be drawn just to park in the bank account and shall not be diverted.
- vi. The UCs/Red D.C Account shall be furnished to the concerned quarters within stipulated time.


