Whereas, on the recommendations of the Services Selection Board, J&K conveyed vide No. SSB/Secy/Sel/Class- IV/2021/6273-78 dated 18.10.2022 duly endorsed the General Administration Department vide O.M. No. GAD/MTGRDIV/267/2022-09-GAD dated 27.10.2022, among others, Sh. Shahnawaz Manzoor was appointed as MTS (Class - IV) vide Govt. order no. 387-PW(R&B) of 2022 Dated 29-10-2022; and

Whereas, vide Government order No. 387-PW(R&B) of 2022 Dated 29-10-2022, among others, the services of Sh. Shahnawaz Manzoor, MTS (Class - IV) were placed at the disposal of the Chief Engineer, Mechanical & Hospitals Engineering Department, Kashmir; and

Whereas, subsequent to his appointment/ joining, the Chief Engineer, Mechanical. Hospitals and Engineering Department vide his No. letter CE/M&HED/K/Adm/6101-02 dated 26.03.2024 has informed that Sh. Shahnawaz Manzoor(MTS), through the medium of an application dated 22/02/2024 has tendered his resignation from the post of Class-IV (MTS); and

Whereas, the Chief Engineer, Mechanical, Hospitals and Engineering Department forwarded his request to the Public Works (R&B) Department for acceptance of his resignation as the said candidate has been selected as Junior Engineer in PW(R&B) Department; and

Whereas, the matter has been examined/considered with reference to the rules governing the subject and it has been observed that the concerned official is still on probation and has not qualified the prescribed probation period of service.

Whereas, Rule 21(1) of J&K Civil Services (Classification, Control & Appeal), Rules, 1956, provides as under:-

"At any time before the expiry of prescribed period of probation the appointing authority may:

- a. suspend the probation of a probationer and discharge him from the service for want of vacancy; and
- at its discretion terminate the probation of a probationer and discharge him from the service.

Now, therefore, in terms of Rule 21(1) (b) of the J&K Civil Services (Classification, Control & Appeal) Rules, 1956, the probation of Sh. Shahnawaz Manzoor, MTS (Road Worker) S/o Manzoor Ahmad Shah, District Kulgam is hereby terminated and is discharged from Government Service w.e.f. 22.02.2024 on his own request.
