WHEREAS, on the recommendations of J&K Services Selection Board, Er. Molvi Abrar Hussain was appointed as Junior Engineer vide Government Order No. 330-PW(R&B) of 2022 dated: 16/09/2022.

AND-WHEREAS, vide Govt Order No. 330-PW(R&B) of 2022 dated: 16/09/2022, the services of Er. Molvi Abrar Hussain were placed at the disposal of the Chief Engineer, PMGSY (JKRRDA) Kashmir;

AND-WHEREAS, subsequent to his appointment/ joining, the Chief Engineer, PMGSY (JKRRDA) Kashmir vide his letter No. CE/PMGSY/K/Estab/11180-82 dated 26.03.2024 informed that Er. Molvi Abrar Hussain, through the medium of an application dated 01/03/2024 has tendered his resignation from the post of Junior Engineer;

AND-WHEREAS, the Chief Engineer, PMGSY (JKRRDA) Kashmir forwarded his request to the Public Works (R&B) Department for acceptance of his resignation on the personal circumstances that requires his immediate attention;

AND-WHEREAS, the matter has been examined/considered with reference to the rules governing the subject and it has been observed that the concerned official is still on probation and has not qualified the prescribed probation period of service.

AND WHEREAS, Rule 21(1) of J&K Civil Services (Classification, Control & Appeal), Rules, 1956, provides as under:-

"At any time before the expiry of prescribed period of probation the appointing authority may:

- a. suspend the probation of a probationer and discharge him from the service for want of vacancy; and
- b. at its discretion terminate the probation of a probationer and discharge him from the service.

Now, therefore, in exercise of the powers conferred under Rule 21(1) (b) of the J&K Civil Services (Classification, Control & Appeal) Rules, 1956, the probation of Er. Molvi Abrar Hussain S/o Molvi Maqbool Hussain is hereby terminated w.e.f 01.03.2024, and is discharged from the post of Junior Engineer (Civil) in the J&K Engineering Subordinate Service, on his own request.
