Subject: Acceptance of Diploma of Mr. Tariq Mahmood, Works Supervisor (Civil) and inclusion of his name in the seniority list of Diploma holders Works Supervisors (Civil).

Whereas, the department received the case of Mr. Tariq Mahmood, Works Supervisor (Civil) from Chief Engineer, PW(R&B) Jammu for acceptance of his Diploma and inclusion of his name in the seniority list of Diploma holders- Works Supervisors (Civil), his service particulars are given as under:-

Whereas, the case was examined in this department and marks/diploma certificates of the above named official were forwarded to the Registrar, J&K Board of Technical Education, Jammu vide this department's letter dated 21.02.2022 for verification/ authentication & genuineness of the diploma/marks certificates. In response, the Secretary, J&K Board of Technical Education vide his letter No. BOTE/Verif/22/8323 dated 28.02.2022, furnished the verification of the diploma certificate acquired by the above named candidate as genuine.

Whereas, the above named incumbent also produced undertakings in the shape of Affidavit affirming therein that he passed three years Diploma in Civil Engineering from Govt. Boys Polytechnic Bikram Chowk Jammu, Under Roll No.1501-D07T-3751 and the diploma/documents certificates produced by him before the department is genuine and have not been tempered or fabricated.

Whereas, a notice was issued vide No. PW(R&B)/HRM/39/2022 dated 14.03.2022 for inviting therein objections from the members of the cadre who are likely to be affected due to decision of the department. In response, the Chief Engineer PW(R&B) Jammu vide his letter No. CEJ/Estab./s/441-43 dated 09.06.2022, intimated that his office has not received any objections from any person till date after issuance/publication of the notice vide dated 14.03.2022.

Whereas, the case was re-examined in the department and it was decided to accept the Diploma certificates acquired by the above named official, treating him as Diploma holder-Works Supervisor (Civil) and to include his name at appropriate place in the relevant seniority list of Diploma holders-Works Supervisor (Civil) and also exclusion of his name from the relevant seniority list wherever he exists.

Now therefore, Mr. Tariq Mahmood, Works Supervisor (Civil) shall henceforth be treated as Diploma holder-Work Supervisor (Civil) from the date of passing of Diploma i.e 14.04.2008, and subsequently his name shall be included at appropriate place in the seniority list of Diploma holder Works Supervisors (Civil) as and when the same is notified afresh by the Administrative Department, consequently his name shall deemed to be deleted from the general seniority list of Works Supervisors (Civil) maintained in the Chief Engineer's Office, Jammu.
