Whereas, on the recommendations of the Services Selection Board, J&K conveyed vide No. SSB/Secy/Sel/Class- IV/2021/6273-78 dated 18.10.2022 and the General Administration Department's O.M. No. GAD/MTGRDIV/267/2022-09-GAD dated 27.10.2022, among others, Shri Waseem Sajad (MTS) was appointed as Class IV (MTS) vide Government order No. 386-PW(R&B) of 2022 dated 29.10.2021 ; and

Whereas, vide Government order No. 386-PW(R&B) of 2022 dated 29.10.2022, among others, the services of Shri Waseem Sajad (MTS) , Road worker were placed at the disposal of the Chief Engineer, Mughal Road Organization for further posting, who has joined there on 03.11.2022; and

Whereas, subsequent to his appointment/ joining, the Chief Engineer, Mughal Road vide his letter No. CEMRP/466-68 dated: 12.06.2023 has informed that Shri Waseem Sajad (MTS) , Road worker through the medium of an application dated 02-06-2023 has tendered his resignation from the post of Class-IV (MTS); and

Whereas, the Chief Engineer, Mughal Road forwarded his request to the Public Works (R&B) Department for acceptance of his resignation as the said candidate has been selected as Constable in Jammu and Kashmir Police (Border Battalion) ; and

Whereas, the matter has been examined/ considered with reference to the rules governing the subject and it has been observed that the concerned official is still on probation and has not qualified the prescribed probation period of service; and

Whereas, Rule 21(1) of J&K Civil Services (Classification, Control & Appeal), Rules, 1956, provides as under:-

"At any time before the expiry of prescribed period of probation the appointing authority may:

- a) suspend the probation of a probationer and discharge him from the service for want of vacancy; and**
- b) at its discretion terminate the probation of a probationer and discharge him from the service.**

Now, therefore, in exercise of the powers conferred under Rule 21(1) (b) of the J&K Civil Services (Classification, Control & Appeal) Rules, 1956, the resignation tendered by Shri Waseem Sajad, Class-IV (MTS) is hereby accepted and is discharged from the Government service w.e.f 02.06.2023 on his own request.


