Sanction is hereby accorded to the:

- i. Withdrawal of Drawing & Disbursing Powers from Executive Engineer Gulmarg Development Authority, Tangmarg of (R&B) Special Sub-Division Magam extended vide Government order No. 140 -PW(R&B) of 2022 dated 20.04.2022.
- ii. Delegation of Drawing & Disbursing Powers in favour of Executive Engineer R&B Special Sub- Division Magam transferred vide Government Order No. 214-PW(R&B) of 2022 dated.30.06.2022 in respect of Revenue and Capital Expenditure Budget placed at his disposal by Controlling Officer under different Head of Accounts. The DDO powers delegated to the officer are governed by Govt. Order No. 100-F of 2016 dated 30/03/2016. The Executive Engineer concerned shall operate the funds placed at his disposal by the Controlling officer/Competent authority upon the Treasury Narbal.

The DDO powers delegated are subject to fulfillment of following conditions.

- a) That he shall operate on the treasury to the extend funds are placed at his disposal by the competent authority.
- b) That all the codal formalities should be fulfilled while incurring the expenditure.
- c) That no excess over allotment/irregular expenditure is made by the DDO.
- d) That the concerned DDO shall ensure submission of the Accounts to the different quarter in time.
- e) That the DDO shall submit the monthly Receipt/Expenditure statement to the Administrative Department through controlling Officer.
- f) DDO shall also obtain A.G's Code from the Accountant General, J&K.


