Whereas, on the recommendations of the Services Selection Board, J&K, among others, Mr. Shoaib Ahmad Sheikh was appointed as Class IV (MTS), vide Government Order No. 268-PW(R&B) of 2023, dated 23.06.2023; and

Whereas, vide Government Order No. 268-PW(R&B) of 2023, dated 23.06.2023, among others, the services of Mr. Shoaib Ahmad Sheikh (MTS), Road worker were placed at the disposal of the Chief Engineer, Mechanical & Hospital Engineering Department, Kashmir for further posting ; and

Whereas, subsequent to his appointment and joining, the Chief Engineer, Mechanical & Hospital Engineering Department, Kashmir vide his letter No. CE/M&HED/K/Adm/2409-11 dated: 28/08/2024 informed that Mr. Shoaib Ahmad Sheikh (MTS) , Road worker, through the medium of an application has tendered resignation from the post of Class-IV (MTS) w.e.f 24.06.2024; and

Whereas, the Chief Engineer, Mechanical & Hospital Engineering Department Kashmir forwarded his case to this Department for acceptance of his resignation on the grounds that the said candidate has been appointed as Panchayat Secretary in the Rural Development Department vide Government Order No. 268-DRDK of 2024 dated 20.06.2024; and

Whereas, the matter has been examined/ considered with reference to the rules governing the subject and it has been observed that the concerned official is still on probation and has not qualified the prescribed probation period of service; and

Whereas, Rule 21(1) of J&K Civil Services (Classification, Control & Appeal), Rules, 1956, provides as under:-

"At any time before the expiry of prescribed period of probation the appointing authority may:

a. suspend the probation of a probationer and discharge him from the service for want of vacancy; and

b. at its discretion terminate the probation of a probationer and discharge him from the service.

Now, therefore, in terms of Rule 21(1) (b) of the J&K Civil Services (Classification, Control & Appeal) Rules, 1956, the probation of Mr. Shoaib Ahmad Sheikh, MTS (Road Worker) is hereby terminated and is discharged from Government Service w.e.f. 24.06.2024 on his own request.
