On the recommendations of the J&K Service Selection Board endorsed by the General Administration Department and in continuation of the Government Order No. 209-PW(R&B) of 2024 dated 25.07.2024, sanction is hereby accorded to the appointment of **Saliah Rashid D/o Ab. Rashid Parray** (SL.No. 1570, Roll No. 251428213668. DOB-13.06.1998, Category-OM, Domicile- Pulwama) against the post of Multi Tasking Staff (MTS) in the Pay Level SL-1 (14800-47100) in Divisional Cadre, Kashmir in the Public Works (R&B) Department in respective category of nomenclature of the post to be allotted by the concerned Chief Engineer/HOD.

Consequent upon her appointment, the appointee shall report to the Chief Engineer, PW(R&B) Department, South Kashmir within a period of twenty one (21) days from the date of issuance of order. In case the candidate fails to join within the stipulated time period, her appointment shall be deemed to have been cancelled ab-initio without any further notice.

The appointee shall be allowed to join on production of the following documents/certificates (in original) to be verified subsequently:-

- a) Academic/Qualification Certificate.
- b) Matriculation/Date of Birth Certificate issued by the recognized Education Board.
- c) Health Certificate from the concerned Chief Medical Officer of the District.
- d) Domicile Certificate from the Competent Authority.
- e) Valid Relevant Category Certificate, if any applicable.
- f) That if the candidate has availed loan for self employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counseling Centre of the domicile District, the appointee shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self employment unit/enterprise before joining the Government service. The appointee shall be required to repay the entire loan liability/in suitable EMIs to be worked out by the DDO concerned from her salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a

self employment unit/enterprise and recovery to be made and also personally monitor its recovery in terms of Circular No. 06-JK(GAD) of 2023 dated 06.02.2023 issued by the General Administration Department.

The appointment of the candidate shall further be subject to the following conditions:-

- i. The appointee shall furnish an undertaking in the shape of an affidavit to the effect that the appointee have no criminal record and is not facing any criminal proceedings in any court of law.
- ii. If on verification of the qualification certificates/DOB and other documents from the concerned issuing authority are proved fake/forged, the claim of the appointee for appointment shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against his/her.
- iii. The salary of the appointee shall not be drawn and disbursed to her, unless satisfactory report in respect of genuineness of qualification/date of birth/relevant category certificate is received from the concerned issuing authority.
- iv. The appointment of the candidate shall be governed by the New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.
- v. The appointee shall be on probation for a period of 02 years.
- vi. The cadre/Department allocated by appointing authority/SSB shall not be changed under any circumstances by any authority/Department.
- vii. The appointment shall be cancelled ab-initio, if it is found that the candidate is having higher qualification than the prescribed one at any stage later on, he/she shall also be liable for criminal prosecution.
- viii. The appointment of the above candidate shall be subject to outcome of writ petition(s), if any, pending before any competent court of law.
