AND WHEREAS, a corrigendum was issued to the ibid seniority list under endorsement No.PW(R&B)/HRM/14/2017-N-I dated 08.10.2020, in the following manner:-

a. "The name of Ms. Sadia Rasool, Works Supervisor figuring at seniority No.16 in the Annexure to Government Order No.205-PW(R&B) of 2020 dated 22.07.2020 shall be deemed to have been excluded from seniority list of Draftsman (Civil) and her name with particulars shall be deemed to have been included at Seniority No.5(A) in between Mr. Mansoor Ahmad Mir and Mr. Tilak Raj in the seniority list of works supervisor (Civil) in the said Government Order.

b. The complete Service particulars against seniority No.2 of draftsman (Mechanical) in Annexure to Government Order No.205-PW(R&B) of 2020 dated 22.07.2020 shall always be deemed to have been incorporated as under:

c. The designation of Mr.Suraj Singh, I/c Junior Engineer (Civil) figuring at seniority No.19 may kindly be read as I/c Junior Engineer (Civil) instead of Draftsman (Civil) appeared in the Annexure to Government Order No.205-PW(R&B) of 2020 dated 22.07.2020".

AND WHEREAS, a Departmental Promotion Committee meeting was convened on 13.12.2023 for considering regularization of the members figuring in the above said seniority list, as Junior Engineers (Civil/ Mechanical);

AND WHEREAS, during the course of meeting, it was observed by the Departmental Promotion Committee that many members have not furnished the requisite documents required for considering their regularization and after deliberations /discussions, the Committee decided to provide a final opportunity to such members figuring in the seniority list, to submit the requisite documents;

AND WHEREAS, as a sequel, a Notice was issued on 22.05.2024, wherein all eligible members were directed to submit requisite documents such as APRs on JKPWDOMS for the consideration of their regularization by the Departmental Promotion Committee. However, various objections were received in the Department against the seniority list issued vide Government Order No. 205-PW(R&B) of 2020 dated 22.07.2020 and after examination, the following has been observed:

2	Mr.Tilak Raj Raina, I/C Junior Engineer(M) has submitted that he was appointed as draftsman vide Government Order No. 405 -PW of 1992 dated 1-12-1992 and acquired 3 years diploma in Mechanical Engineering in the session May-June-2009 from J&K Board of Technical Education and has been placed below draftsmen namely Bharat Bhushan, Kailash Kumar Pushp, Romesh Kotwal, who have been appointed in the year 2004 and acquired three years diploma from the same Board and in the same session, however, while framing the Seniority list their date of passing of 3 years diploma in Mech Engineering, is taken as 6/2009 whileas in his case date of passing of 3 years diploma has been shown as August to deprive him from proper position in the Seniority list issued vide Govt. Order No. 205-PW(R&B) of 2020 dated. 22.07.2022, and needs to be corrected. Accordingly Mr. Tilak Raj Raina I/c Junior Engineer submitted that on the error in the seniority list that has been published his name has been placed at lower position than it should be and it needs to be corrected.	appointee of 1992 batch as Draftsman (Mech). He has done his 3 years Diploma in Mechanical Engineering in the year 2009 (May-June), through J&K State Board of Technical Education. However, in the Final Seniority list of Works supervisors, Draftsmen and Shift Attendants/Field Workers/ Field Supervisores, issued vide Government Order No. 205-PW(R&B) of 2020 dated 22.07.2020, the official has been shown at Sr.No. 7 with the date of passing of Diploma has been mentioned as

Mr. Bharat Bhushan Sharma has submitted a 3 representation wherein the official has submitted that he was appointed as Draftsman (Mech) vide Government Order No. 322-PW of 2000 dated 31.08.2000 after acquiring three years diploma in Institute Engineering from Mechanical & Computer Science, Jammu Engineering (Technical State Board of Education J&K, he was placed as I/c Junior Engineer (Mech) vide Government Order No. 26-PW(R&B) of 2014 dated. 16-01-2014. However, as per final notice issued by the department for regularization and promotion of I/c Junior Engineers on 22.05.2024, he did not find his name at an appropriate place in the list of draftsman (Mech) as his name was shown in the category of Shift Attendant/Field worker/field Supervisor category figuring in serial No. 03.

warrants consideration as per merits of the case.

Bharat Bhushan Sharma is an appointee of 2000 batch as Draftsman Mechanical. The official has passed 3 Diploma years Engineering Mechanical during the session May-June 2009 through J&K State Board of Technical Education. However, in the Final Seniority list of works Supervisors, Draftsmen and Attendants/Field Shift Workers/Field Supervisors, issued Vide Government Order No. 205-PW(R&B) of dated 22.07.2020, 2020 the name of the official figures at Sr. no. 3 under Shift Category of Attendants/Field Works/Field Supervisors. The Claim of the official needs to be considered as per merits of the case.

AND WHEREAS, as also observed by the Departmental Promotion Committee in its meeting on 13.12.2023, service particulars like Date of Birth and Date of Appointment are missing in respect of various members figuring in the Final seniority List issued vide Government Order No. 205-PW(R&B) of 2020 dated 22.07.2020 and requires immediate up-dation.

NOW THEREFORE, a tentative seniority list of Draftsmen (Civil/ Mechanical), Work Supervisors and Shift Attendants/ Field Workers/Field Supervisors, as it stood on 01.06.2020, is hereby notified, forming **Annexure-"A"** to this Order, for inviting objections from the members, if any, and same shall be submitted through the respective Heads of the Departments (HoD's) within a period of 15 days from the date of issuance of this order. Objection received, if any, after expiry the above period, shall not be entertained.
