Revised Administrative Approval is hereby accorded for **"Construction of Major PSC Girder with RCC deck slab type, 2 Lane Bridge with footpath and pipe tray of different spans having an aggregate length of 127 Rms (approx.) over river Jhelum at Qamarwari on Khanyar to Qamarwari road (Nallah Mar Road, Srinagar)" under Bridge Programme for an amount of Rs 1277.14 lakh as per the details / cost abstract of the bridge enclosed as Annexure "A" to this order:**

The revised Administrative Approval is subject to the fulfillment of following conditions:-

1. That the project is strictly devised and designed as per latest relevant I.S. Codes and specifications of MoRTH/PWD/Engineering Manual 2020/CPWD and as per **J&K Bridge Manual, 2022** and same is authenticated and proof checked by the competent authority (NIT/DIQC), before taking up execution in hand.
2. That the work shall be executed after observing all Codal/procedural formalities.
3. That the detailed estimate of work shall be technically sanctioned by the competent authority.
4. It must be ensured that there shall be no multisource funding or overlapping of schemes under different programmes.
5. That no diversion of funds from one scheme to another scheme shall be made.
6. That the funds shall be released by the controlling officer to the extent of actual work done as per approved provisions in the estimate after fulfilling all Codal /procedural formalities.
7. That the lump-sum provisions, either in terms of percentage or fixed as made for certain components of the DPR are provisional and shall be subject to detailed estimates based on actual

- details/requirements and relevant rates, to be framed and approved by competent authorities in accordance with set codal procedures.
8. That the rates for the items, not covered in JK SSR or any other relevant schedule, shall conform to Analysis of rates based on authentic Data Book, to be computed and approved by the competent authority well before invitation of tenders in accordance with set codal procedures.
 9. That the inventory of serviceable material got from dismantling shall be made & taken on books or cost of serviceable material be deducted.
 10. That the working BOQs, based on approved design details/requirements, are framed as per J&K PWD Schedule of Rates for e-tendering purpose of the Project.
 11. The cost revision is allowed strictly as per provisions of GFR/ Manual for Procurement of Works and terms and conditions stipulated in the bid document.
